Postsecondary institutions that participated in and disbursed state scholarship and grant funds are required to comply with the Program Compliance Audit for State Student Financial Assistance Programs for the fiscal year 2019-20. Audit compliance is mandated under:

- Section 215.97, Florida Statutes, Florida Single Audit Act;
- Chapter 10.650, Rules of the Auditor General; and
- Chapter 6A-20.0021, Rules of the State Board of Education.
