**SUBJECT: 2025-26 FSAG Program Allocations** 

The 2025 Florida Legislature appropriated over \$269 million for the FSAG Programs to assist students for the 2025-26 academic year. Your institution's annual allocation may be found by logging onto the State Student Financial Aid Database (SSFAD) and reviewing the Payment Summary screen for the FSAG fund. Annual allocations are split evenly across each of your terms. For example, semester institutions will find that their fall term (Term 1) amount will represent 50 percent of their annual allocation.

The deadline date for reporting all awarded students, in addition to all Otherwise Eligible (C99) students, is within 30 days after the end of the regular registration period for each term. The deadline date to reconcile and return all undisbursed funds is within 60 days after the end of the regular registration period for the spring term. An exception is given to postsecondary institutions that document to the Florida Department of Education how they plan to disburse awards during the subsequent summer term. If funds are remaining from your institution's fall and winter/spring terms, summer term awards are allowed to be provided to students who received an award in the fall or spring term. To be eligible for summer term disbursement, postsecondary institutions must submit the FSAG Summer Disbursement Request in SSFAD within 60 days after the end of the regular registration period of the spring term.

The attached 2025-26 FSAG Awards matrix outlines the sector Student Aid Index (SAI), Annual Maximum Award Amount, and Term Type with corresponding term award amounts based on enrolled credit hours.

- The maximum SAI for the public, private, and postsecondary sectors is 9984.
- The annual maximum award amount is \$3,260, with a minimum award of \$200.
- Public part-time students are eligible if they enroll for a minimum of six hours per term.
- Talented Twenty students are considered a priority for FSAG funding.
